### Terms & Conditions

1. All membership packages are non-transferable.
2. Membership passes can not be used in conjunction with a corporate or private golf tournament held at the club.
3. Proper dress code and club rules must be adhered to at all times.
4. Membership card must be presented prior to each golf round.
5. No outside food or drink is permitted on the premises.
6. Seven-day memberships are permitted play any time with no time restrictions
7. Twilight members are permitted play seven days a week, one hour prior to public twilight times.
8. Corporate memberships consist of four assigned adults and membership cards are non-transferable.
9. Couple memberships consist of two adults residing in the same residence. Proof of identification may be required.
10. All members have Two week advance tee time booking.
11. G.A.O memberships available at additional cost.
12. The member, in consideration of the club permitting the use of their facilities, agree(s) as follows:
  - a) To waive any and all claims, by whatsoever cause that I/we may in the future have against the Club and its directors, officers, employees, agents and representatives (all of whom are hereinafter collectively referred to as the “releasees”).
  - b) To release the releasees from any and all liability for any loss, damage, injury or expense that I/we may suffer as a result of or arising out of our use of the golf and Club facilities due to any cause whatsoever, including negligence on the part of the releasees.
  - c) To hold harmless and indemnify the releasees from any and all liability for any property damage or personal or bodily injury to any third party resulting from or arising out of the members use of the club.
  - d) I/We are liable for and responsible for any damage that may be caused to the fixtures, furnishings and other property of the Club as a result of member(s) usage. The member(s) agrees to abide by all reasonable rules and regulations established by the Club for the purpose of regulating the use of the above facilities; and also to comply with the rules and regulations of the Liquor Control Board of Ontario. The Club will not be held responsible for articles left in the building regardless of cause.
14. Failure to adhere to club rules may result in forfeit of golfing privileges.
